Chairwoman Williams opened the floor for public comment.

Gypsy Wanna asked about "rumors of who got free tuition". Chairwoman Williams allowed President Holmes to address this question. To which Dr. Holmes stated that no particular students received free tuition.

Gypsy Wanna asked "Why are there two board meetings per month". Chairwoman Williams responded by informing Gypsy Wanna that there are two meetings per month due to all portions of the bylaws being active at this time.

DISCUSSION ITEMS

AIHEC Legislative Summit, Washington DC:

The President attended the 2025 AIHEC Legislative Summit alongside three members from student senate. Student Senate President, Emily Johnson, spoke about what she learned during the Legislative Summit. She learned about how the freezing of federal funding affects Tribal Colleges and Universities. Also, added that she learned more about TCUs in general. The President informed the board that the freeze affects SWC directly by not allowing the college to draw down on certain funds such as equity. Also denies the college from getting funding from head start. A judge in a federal court issued a stay making funds available as of right now. If there were to be lawsuits, they would be class-action lawsuits, also there would not be payouts to colleges or universities only to students and employees. The President left Washington knowing for sure that funding will be cut eventually. The question to be answered is where will the cuts be and how much. At the AIHEC Legislative Summit the President was issued a "request for resolution to support Tribal Colleges and Universities." She presented it to the board. Madam Chair instructs the Tribal Council Ex. Officio to speak to the tribe in regards to this form and ask if the tribe is willing to adopt the resolution. Madam Chair also instructed the President to present it to the SWO Board of Regents. Tribal Council Ex. Officio suggests that the President gives create a list of possibilities and how this affects SWC.

HLC Conference- April 2025

The new criteria for accreditation goes into affect September 1, 2025. The college is gearing up and preparing for the visit with the Higher Learning Commission in 2027 for accreditation purposes. At the 2025 HLC Conference 2/3 of the special sections are designated for TCUs. The President, 3 board members, and 6 staff members will attend the HLC Conference in April 2025.

HLC Focus Follow Up Visit Letter

The visit with the HLC is in 2027. All documents must be turned in by 2026 at least 3-4 months before the scheduled visit. There's normally a minimum requirement of 5 years of data.

Board of Trustees Annual Conflict of Interest Statement

The conflict of interest statement is looked over each year. Signatures of each board member are required. The BOT Annual Conflict of Interest Statement was tabled by a Trustee.

Big Coulee District:

- → Were 29 employees terminated? Dr. Holmes responded: "No there were not 29 terminations."

Buffalo Lake District:
