Chairwoman Williams called the meeting to order at 5:10 PM. Roll call was taken and a quorum was established.

## **Motion 1:**

### **Motion 3:**

Motion made by Heipa to approve the agenda, second by Old Agency, question by Long Hollow. Motion voted passed.

Reading of the mission statement.

Chairwoman Williams opened the floor for public comment.

Chairwoman Williams informs the public that the SWC Board of Trustees operates in the best interest of the college, and that public comments are not to include names of students, faculty, or staff at SWC.

Trustee Owen suggests openness and honesty, referring to no executive is required but to speak freely now as long as there are no names included just policies and procedures addressed.

#### **Motion 4:**

Motion made by Long Hollow to keep the floor open to address concerns and complaints, second by Heipa, question by Enemy Swim. Motion voted passed.

Public comments were replaced with an open forum where members of the community expressed their concerns about 32 resignations or terminations, finances and expenditures, due process of hiring, firing, and changing of job descriptions, positions being erased, grievances process, employee tuition waivers, and the radio station's removal from SWC property.

- SWC was a co-host to this year's AIHEC Student Conference.
- There were 14 students from SWC in attendance, along with 7 staff & faculty members who stepped in as coaches, mentors, and helping hands.

- Kaci Neilan was recognized as SWC's Coca Cola Scholar.
- SWC Women's Archery won 3<sup>rd</sup> place.

- Gracelyn Renville won 3<sup>rd</sup> place in the 5k run.

#### PRESIDENT'S REPORT

- There is a new and more effective room layout for board meetings that allows everyone in the room to hear and see the BOT during meetings.
- There is exciting and useful information to come in the 2025 HLC Conference that will be held in Chicago.
- There will be an extra day specifically for meetings and discussions with BOT Members and Presidents at the 2025 HLC Conference.
- There was an appreciation and farewell luncheon held for Vince Owen. A long-time employee with the college who helped out in any way possible and served the students with dignity and respect. He will be missed.

- Tammy Decoteau was honored for women's history month and for her contribution to the community and the Dakota Language on 3/5/25 at 12:00 pm in the student union. "Preserving the past, Preparing for the future."
- Dakota Studies Family Night is to be held on 3/19/25 in classroom 9, 5:00-9:00 pm presented by Harvey DuMarce. The topic of discussion "Blood Quantum: Identity, Culture, Sovereignty, and the future.
- The SWC Mustangs are hosting a basketball academy each Monday 5:30-7:00 pm for boys, and Wednesday 5:30-7:00 pm for girls. Beginning 2/24, and lasting until 4/2/25.
- National Soup Day was celebrated on 3/3/25. There was free soup for students, faculty, staff, and any members of the community who came out to support.
- National Oreo Day was celebrated 3/5/25 outside of the student union. Students stopped by and grabbed Oreos and indulged in fried Oreos by TJ Shellman.

## VICE PRESIDENT OF ACADEMIC & STUDENT AFFAIRS' REPORT

- 260 students pre-drop, 241 students post-drop for fall. Of the 241 students we have, 142 are full time, 99 are part time. 173 students are SWO members, 31 other tribes, 4 lineal descent and 29 are mom-tribal.
- There are 23 students from Big Coulee, 18 from Buffalo Lake, 23 from Enemy Swim, 28 from Lake Traverse, 23 from Long Hollow, 36 from Old Agency, 18 from Veblen/Heipa, and 4 are unknown.
- The graduation committee has been meeting. Graduation will be held on campus on May 17, 2025. We anticipate about 40-50 graduates.
- We are working on Workforce Development. The program consists of 12 credits. It is for students who want to learn basic life skills.
- We are working on the Casino Management to be approved by the Curriculum Committee.
- We are having a human trafficking seminar via zoom on March 21<sup>st</sup> at 9:00- 11:00 am.
- Accreditation reaffirmation committees have been formed, each committee will work on the new criteria.
- The reorganization of the college into academic schools with a Dean leading each school is underway.
- Interviews were held for the Academic Deans of each school. The anticipated start date for the Deans is March 17, 2025.
