### STUDENT SUCCESS: PRESIDENT'S AND DEAN'S LIST

- Students who achieved the accomplishment of sustaining a minimum 12 credit hours with a 3.5 GPA for the Fall 2024 semester made the Dean's list. These students were announced individually and awarded with a check for \$100, an SWC T-Shirt, and an opportunity to shake the hand and greet each SWC Trustee.
- Students who achieved the accomplishment of sustaining a minimum 12 credit hours with a 4.0 GPA for the Fall 2024 semester made the President's list. These students were announced individually and awarded with a check for \$150, an SWC T-Shirt, a 4.0 plaque with their name on it, and an opportunity to shake the hand and greet each SWC Trustee.
